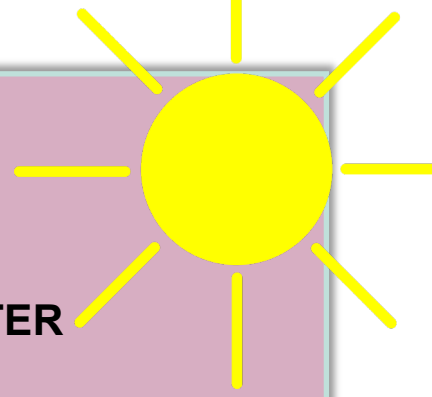




# Tuition

### \*Description of Rates and Fees:

- A 10% discount is applied to tuition, bank day credit and drop-in fees for families that have a second child enrolled in either the Daycare Program or Preschool Program. The discount will be applied to the oldest child's tuition rates. This discount does not apply to the FCA Before and After School Program.
- An \$100.00 non-refundable enrollment fee per family is collected upon application for enrollment. Annual re-enrollment fees of \$100.00 will be assessed each August for all re-enrolling families.
- Late pick-up fees are assessed after the child is picked up from the classroom and signed out. The amount of \$20.00 per child, per 15 minutes or portion thereof, will be assessed to the account.
- An annual books and materials fee of \$50.00 per child is billed each August for all children enrolled in the Shining Lights classroom. The fee covers curriculum for each child and materials used throughout the school year.
- A \$35.00 non-refundable NSF fee will be added for ACH payments returned due to insufficient funds, or declined credit card payments.
- A \$40.00 late fee will be assessed if payment in full is not received when due.
- Activity fees are billed each September for all children in the Shining Lights classroom to cover field trips and other activities throughout the school year. Summer fun activity fees are billed each April to cover Summer Program activities.
- Payments for ½ monthly tuition and fees will be debited on the 3rd and the 17th of each month, or one business day prior if the payment day falls on a holiday or weekend.
